TERMS AND CONDITIONS

2. The method of payment shall be United States dollars and submitted with the order for service. Capture Technologies will accept checks drawn on banks located in the United States of America or certified funds. All orders require a valid credit card upon order.
3. Cancellation – All orders are subject to a \$50.00 cancellation fee. Orders cancelled within 30 days of the show will **NOT** be refunded.
4. The Customer agrees to pick up the Equipment from the Capture Technologies service desk one day before the official hall opening. Capture Technologies will furnish its equipment to the customer in good working order and the customer agrees to return the equipment to Capture Technologies in the same condition. The Customer agrees to the immediate payment, upon request by Capture Technologies for all damages or loss of Capture Technologies equipment, except such as may result from normal operation thereof; and the Customer acknowledges and understands that the total replacement cost of the equipment, selected on the reverse side, will be applicable as follows: LeadWare Magnetic Stripe Reader: \$250.00; LeadWare Barcode Scanner: \$1100.00; LeadWare Pocket Edition Unit: \$1,500.00; LeadWare Pocket Edition Unit Battery: \$ 56.00; LeadWare Pocket Edition Unit Power Supply: \$40.00; LeadWare Pocket Edition Unit Stylus: \$15.00; LeadWare Pocket Edition Adapter Cup: \$70.00; LeadWare Pocket Edition Hand Strap: \$6.00; LeadWare Pocket Edition Case: \$25.00. **THE CUSTOMER AUTHORIZES CAPTURE TECHNOLOGIES TO CHARGE THE CREDIT CARD \$500.00 FOR FAILURE TO RETURN THE EQUIPMENT WITHIN TWO HOURS AFTER THE OFFICIAL HALL CLOSING. Minimum System Requirements – The customer agrees to run LeadWare on a computer with the minimum system requirements as follows: **Operating System:** Windows 2000 SP2, Windows XP SP2, Windows XP Tablet Edition, Windows Vista (All operating systems should include all critical operating system updates); **Processor:** Intel® Pentium® II processor (Pentium III or higher is recommended); **RAM:** 128 MB of RAM (512 MB RAM is recommended); **Available Disk Space:** 150 MB of free hard drive space; **CD-ROM Drive:** 4x or higher; **Monitor:** VGA or higher resolution monitor, with 1024x768 pixel resolution; **Mouse:** Microsoft™ mouse, or other compatible pointing device; **Peripheral Interfaces:** 1 free USB port (2 recommended), 1 free serial port (2 recommended).
